**Submitting An Application**

- Applications will be accepted by US Post Office mail **ONLY**. The order of receiving the application will not affect whether or not you will be placed on the wait list or the order of placement. The date we get your application does not matter, as long as it is postmarked by August 15, 2014.
- Please do not submit duplicate applications.
- Applications must be postmarked no later than Friday, August 15, 2014.
- Only fully completed 2014 Applications will be placed on the Waiting List.
- All the applications will be placed together and 1000 random applications will be drawn for placement on the Waiting List.

**Lottery Drawing**

- A public lottery drawing will be conducted on Friday, August 29, 2014 beginning at 9:00 a.m. at WHA Offices at 1524 South 16<sup>th</sup> Street
- Duplicate applications will receive only one placement on the list.
- The order of placement on the Waiting List will be decided by a random drawing.
- WHA will not be responsible for applications that are received after the August 29th drawing.

**Notification**

- Applications chosen in the lottery drawing will be notified by mail of their placement.
- Applications not chosen in the lottery will **NOT** be notified or placed on the Waiting List.
- Applications not chosen will be free to apply at the next opening of the Waiting List.
